Permits . Ordinances . Applications

The Board of Supervisors has adopted ordinances that regulate land use in the township. These include: zoning, flood plain, building, and most recently storm-water management. Whether constructing a building or installing a driveway, you may not intentionally direct water from your property to roadside ditches *or* onto neighboring properties. Planning ahead can save you time and money. Before starting any work, please contact the township secretary for a review of the permits required for your specific project.

In addition, residents on township roads are required to obtain a highway occupancy permit *prior* to installing, repairing or replacing a driveway. Some examples of driveway projects are blacktopping and/or changing pipes. Additional information and downloadable zoning, stormwater, and driveway applications are available on our website.

The township contracts Building Inspectors Underwriters, Inc. (BIU) to administer the statewide building code. They can be reached at 814-860-8044.

Regulations for Storage Sheds & Swimming Pools

You may place *one (1) portable* shed within your side *or* rear yard. Shed Specs: Up to 144 sq. feet, and no closer to the property line than it is tall. If you don't meet the above specifications, you will need to obtain a zoning permit.

If you are considering building or installing a swimming pool on your property, please call the township Zoning Administrator for permit requirements and fees. This also applies to swimming pool decks.

Recycling and Trash Collection

Wayne Township residents have access to single-stream recycling containers at the Elgin Beaverdam Fire Dept. 24 hours/day 7 days/week. Please keep in mind that items for recycling include newspapers, magazines, plastic items containing the recycling symbol, jars, and cans. *No trash please.*

For e-Waste and Household Hazardous Waste (HHW) items, the Erie County Recycling Center (ECRC) holds monthly collections. Pre-registration is *required* for each event >> Call **866-815-0016**. ECRC's website: eriecountyrecycling.com.

In previous years, Wayne Township has sponsored tire collections and eCycle events locally. Future events will be announced on our website and in the Corry Journal.

Two private Trash Collection Companies may service the Wayne Township residents: Advanced Disposal (formerly Veolia) **888-262-4910** and Waste Management **877-823-1030**. Please call either of those two companies to set up your trash collection schedule.

Tax Collection

Berkheimer & Associates collects your local Earned Income Tax. As a resident of Wayne Township, your **Act 32 PSD Code is 250106**. This *very important* number identifies your place of residency as being in the Erie County Tax Collection District, Corry Area School District, and Wayne Township. Please be sure you have filed a correct, up-to-date *Residency Certification Form* with your employer, and enter the correct residency info on your annual tax return.
